LAKE VILLAGE SWIMMING POOL FACILITY

The Association swimming pool facility is available for the use of Owners, Tenants, Occupants and Guests. The swimming pool is located adjacent to the Club House near the intersection of Rancho Vista Road and Mira Loma Drive at 30151 Rancho Vista Road, Temecula, CA 92592.

THE POOL FACILITY INCLUDES:

- The Pool itself and the surrounding Deck Areas
 - Deck Chairs
 - Drinking Fountain
 - Shade Areas
 - Rest Rooms and Showers

HOURS

Pool hours are 6:00 AM to 10:00 PM. The pool is heated from May 1st until October 1st

POOL RULES

1. A valid Association Keycard or Fob is required in order to enter the pool area and to use the rest rooms.
2. Owners, Tenants and Occupants must accompany and stay with their guests.
3. No more than six (6) guests per lot are allowed to use the pool at any one time.
4. No lifeguard services are provided. Proper supervision is required. Weak, inexperienced or non-swimmers must be accompanied by a responsible person who is of sufficient maturity, size and swimming ability to provide assistance in the event of distress or emergency.
5. No Lifeguard on Duty. Children under the age of 14 shall not use pool without a parent or adult guardian in attendance. (California Building Code §3120B.4). All swimmers are encouraged to use the buddy system.
6. No pets are allowed in the pool or the surrounding pool deck area. An exception will be made for any individual(s) who require(s) the assistance of a "service or assistance animal", but any service animal will not be allowed to enter the pool.
7. All smoking, vaping, and use of e-cigarettes is prohibited in all Common Areas (interior or exterior). "Smoking" shall include, but not be limited to, any practice by which a substance, whether tobacco, marijuana or any other substance,

is burned for the purpose of inhaling its smoke. "Vaping" means inhaling water vapor to obtain nicotine, cannabis or any other substance. "E-cigarette" means an electronic device that vaporizes liquid nicotine, cannabis or any other substance. Alcoholic beverages are not permitted in the pool area. No glass containers are allowed in the pool area.

8. Bicycles, skateboards, scooters, razor scooters, roller blades, or roller skates are no permitted at the pool area.

POLICY FOR USE OF THE POOL

Policy has been established for the safety and enjoyment of all when using the pool.

1. Proper swim-wear must be worn. No cut offs. Garment must be designed as swim-wear.
2. Nudity is prohibited in the Common Areas.
3. All incontinent persons (persons unable to control their bladders or bowels) and all persons having currently active diarrhea or who have had active diarrhea within the previous 14 days shall not be allowed to enter the pool water." Note that swim diapers and swim pants are unsatisfactory. Please comply with the County of Riverside mandated rules attached to the Pool Facility entrance gate.
4. In the event of any incident involving Injury, Accident or Emergency, please use any device available to DIAL 911 and follow instructions of the 911 Operator. The address of the pool facility is 30151 Rancho Vista Road, Temecula, CA 92592. The nearest intersection is Mira Loma Drive. Also report the incident to the Management Company whose phone number can be found on the Bulletin Board near the entrance to the Club House.
5. **NO LIFEGUARD ON DUTY.** Users of the pool, lake and Association dock, do so at their own risk.
